# **Italy's VC deals in H1 2024**




Italian venture capital investments amounted to **€2.57 billion**, spread across 339 deals (see [the 2022 Venture Capital Report by BeBeez here](#)), and even further from the peak of **2021**, when investments totaled **€2.9 billion**, spread across 535 rounds (see [the 2021 Venture Capital Report by BeBeez here](#)). As always, the data is collected by [BeBeez Private Data](#) (the BeBeez database available by subscription, [click here for information and to upgrade your BeBeez News Premium subscription](#)).

On the other hand, there have been **no mega-rounds worth several hundreds of millions**, and only four rounds have reached at least the €100 million or dollar threshold: [Bending Spoons](#) with \$155 million, [Medical Microinstruments](#) with \$110 million, [D-Orbit](#) with €100 million, and [Nozomi Networks](#) with \$100 million.

There were **127 venture capital rounds** announced in **H1 2024** by Italian-origin startups or scaleups, meaning companies founded by Italians, though not necessarily based in Italy, for a **total of just under €940 million**, distributed almost evenly between the first and second quarters (around €499 million in the first quarter and €440 million in the second).

This figure, if repeated in H2, would lead to a **recovery in volumes compared to 2023** (see [the 2023 Venture Capital Report by BeBeez here](#)), when investments totaled **€1.536 billion**, although the number of rounds seems to have decreased: last year, there were **327** rounds, more than double the number in the first six months of 2024. That said, the fundraising figure is still far from the total for **2022**, when



The Italian figures are consistent with the **European trend**. According to **PitchBook**, in the first half of the year, venture capital investments (preliminary data) amounted to **€28.9 billion in Europe**, which is less than half of the **€60.8 billion in 2023** and far from the **records of €105 billion in 2022** and **€108.6 billion in 2021**. The same is true for the number of rounds, which reached 4,075 in the first six

months of 2024, down from 10,935 for all of 2023, and from 14,713 and 13,977 in 2021 and 2022, respectively.

The trend of reduced venture capital investment activity is, moreover, a global phenomenon. According to **PitchBook** data, **global venture capital investments collapsed to \$345 billion in 2023** from **\$531 billion in 2022**, and the decline in fundraising has been even more pronounced, with venture capital firms raising just \$161 billion compared to \$307 billion the previous year. In Europe, investments almost halved, falling to €57.2 billion in 2023 from €104.8 billion in 2022.

Returning to Italy, **venture debt**, which had already seen little activity last year, recording only around €95 million in total investments, has been even less present this year, with **just three announced deals totaling €4.6 million**. This pales in comparison to the **€600 million of 2022**. However, in 2022, the statistics were inflated by the mega-round from **Bending Spoons**, which secured €300 million in venture debt as part of the €340 million round announced in September (see [here a previous article by BeBeez](#)). Also in 2022, the Buy-Now-Pay-Later fintech giant **Scalapay** raised \$284 million in venture debt as part of the \$497 million round completed in February 2022 (see [here a previous](#)

[article by BeBeez](#). Scalapay, until the end of 2022 and the first part of 2023, financed its merchant clients through credit securitizations, with the ABS (asset-backed securities) always subscribed by Scalapay itself (see [the BeBeez Magazine article of April 1, 2023, here](#)).

However, it should be noted that *BeBeez* does not count venture debt structured as securitizations underwritten by third-party investors, intended for the financing of loan purchases for SMEs through fintech platforms. This is not considered infact direct fundraising by startups and scaleups. If this were the case, the fundraising statistics would expand by several hundred million euros. For example, recently, [Crescitalia](#) launched two new securitization programs with partly-paid ABS totaling €250 million, in which **illimity Bank** is an investor, while in November 2023, [Opyn](#) launched a new securitization with partly-paid ABS totaling €300 million, with **Azimut, Natixis CIB, and again illimity** as investors.

There is also **growing M&A activity** among Italian-origin startups, both directly by investors and indirectly by portfolio companies of venture capital and private equity investors. Specifically, in H1 2024 there were 11 M&A transactions involving Italian startups or scaleups, or those founded by Italians, by Italian investors (compared to 15 in all of 2023, 20 in all of 2022, and 5 in all of 2021), and one transaction by foreign investors (compared to 6 in all of 2023, 3 in all of 2022, and 6 in all of 2021). Meanwhile, there were 131 **add-on transactions** involving Italian startups or scaleups by Italian companies in venture or private equity portfolios (compared to 16 in all of 2023, 19 in 2022, and 5 in 2021), and 5 involving foreign startups or scaleups (compared to 4 in 2023 and 7 in both 2022 and 2021). Regarding foreign targets, Italian investors invested in 16 rounds of foreign startups or scaleups (compared to 9 rounds in 2023, 21 in 2022, and 33 in 2021) and conducted 4 M&A transactions involving foreign startups (compared to 3 in 2023, 4 in 2022, and 15 in 2021).
